### AAA BUILDS ITS OWN APARTMENT AUDIT FIX

### Australian Apartment Advocacy (AAA) is championing an independent apartment audit system to promote apartments as a reliable housing choice.

The Mascot and Opal Towers disaster in 2019 shook the industry, because the apartment sector had been viewed as the most efficient housing solution to the residential supply crisis in most States.

State and Federal governments now need to work with industry and stakeholders, such as AAA, to restore trust in the apartment sector.

AAA's National Living Survey of 3600 apartment owners, first conducted in 2019 and again in 2021, found more than half had discovered defects in their apartments. However in the last two years this has increased by a further 10%.

AAA director Samantha Reece says an independent audit has the potential to be a win for consumers and a win for developers.

## A WELL-KNOWN ISSUE THAT AUTHORITIES **RECOGNISE NEEDS TO BE ADDRESSED**

The Australian Building and Construction Board's (ABCB) December 2021 response to the recommendations of the February 2018 Building Confidence Report by Professor Peter Shergold and Bronwyn Weir, revealed non-compliance with building standards costs Australians an eye-watering \$2.5 billion a year, with \$1.3 billion borne by apartment owners.

The most significant defects were in waterproofing, weather proofing, structures and fire and safety. Addressing these problems could save \$1.5 billion a year - the cost of fixing defects - and would deliver construction industry productivity savings of \$375 million a year, the ABCB found.



ABCB chair Glenys Beauchamp said then that without improved compliance, consumers were being left to foot the bill for defects and non-compliant work.



In the absence of uniform State and Federal government action to introduce a consistent, national independent apartment audit, AAA has convened an international working group to develop an Apartment Audit and Assurance Accreditation Program<sup>™</sup>, the first in Australia.

These audits, conducted during construction until the end of a project, involve AAA accredited auditors conducting quality control inspections in their specialty area, from the moment the engineer's plans are finalised.

The real-time collection of this information creates an opportunity to identify and fix defects during construction. Addressing and rectifying defects to a uniform national standard allows a compliant development to earn AAA Apartment Audit Accreditation.

When complete, the audits will be stored on a virtual platform with all associated planning approvals, building drawings, warranties and the like for strata owners, committees and councils.

### THE BENEFITS

An independent audit program has multiple benefits. It gives buyers assurance their building is properly constructed. If buyers know their developer is committed to the AAA Apartment Audit, it will also give consumers confidence to buy off-the-plan.

There are 2.5 million apartment owners in Australia and they are the most vulnerable home owners. Owners of apartment buildings four storeys or higher are not covered by Home Warranty Insurance -(which comprises of 50%).

AAA Apartment Audits offer the possibility of reduced building insurance premiums and Latent Defect Insurance because developments subject to these audits are effectively de-risking the build.

AAA's Apartment Audit and Assurance Accreditation Program<sup>™</sup> is engaging high-calibre experts and conducting talks with developers to ensure the program is robust and supported.
